CIRCULAR

Commissioner, Central Excise, Kolkata-IV has entered into an Agreement with the Ruby General Hospital, E.M. Bypass, Kasba, Golpark, Kolkata- 700 107 and as per the Agreement, the following facilities shall be offered to the Officers & Staff of Central Excise & Customs, Kolkata:

- 1) The Hospital will provide medical attention to the officers & staff of Central Excise & Customs Kolkata and their dependents and will provide 02(two) Beds and all the Medical attention as may be necessary.
- 2) The Hospital will provide regular medical treatment for all the officers & staff of Central Excise & Customs, Kolkata and their dependents on production of valid Service Card, or with the written approval of the Commissioner of Central Excise, Kolkata-IV or his authorized officer within 72 hrs from the date and time of admission. The Hospital will not insist on any advance payment of the of admission.
- 3) It should be the duty of the Hospital to realize all outstanding dues from all the staff and their dependents(beneficiaries),. The department shall not be liable for any payment arising out of any service rendered by the Hospital.
- 4) The Hospital has agreed to give discounts on the following items :-
 - (i) 20% discount on Indoor & Outdoor investigations
 - (ii) 20% discount on existing health check up packages
 - (iii) 15% discount on bed charges
 - (iv) 10% discount on O.T. charges and packages
 - (v) 5% discount on pharmacy purchase.
- 5) This Agreement is no way concerned with CGHS Rules and Regulations.
- 6) The Agreement has been entered into as a welfare measure to the staff and officers of the Department of Central Excise & Customs of the state of West Bengal.
