In terms of OM No. 35034/3/2008-Estt(D) dated 19th May 2009 of Department of Personnel and Training, Ministry of Personnel, Public Grievances and Pensions, as forwarded by CBEC Vide F.No. A32011/5/2009-Ad.III A dated 26th June 2009 and DoPT OM No. 35034/3/2015 dated 28th September 2016 in respect of grant of financial up gradation under Modified Assured Career Progression Scheme (MACPS), the under mentioned Inspectors as detailed under the cadre control of CGST and Central Excise Kolkata Zone have been recommended 'FIT' by the Departmental Screening Committee (DSC) in its meeting held on 27.05.2019 and 28.05.2019 for grant of 1st , 2nd, 3rd financial up-gradation (as applicable) under MACP Scheme 2009. The VC/IC as per due date mentioned above in the column of remarks should be obtained before extending the benefit of financial up-gradation under MACP Scheme.

The following terms and condition shall also apply:

1. The MACPS envisages merely placement in the immediate next higher level in the Pay Matrix as given in PART A of Schedule of the CCS (Revised Pay) Rules, 2016.
2. The financial up-gradation envisages retention of old designation and does not confer privileges relating to higher status.
3. The financial up-gradation under the MACP Scheme shall be purely personal to the employees concerned and shall have no relevance to his/her seniority position.
4. Pay fixation in the higher scale be done under the provision of FR-22(1), (a)(i). As such, no fixation benefit shall accrue at the time of regular promotion.

5. Grant of higher grade pay(through financial benefit) may change consequent upon receipt of any clarification or found inadmissible for any reason. The excess payment, if any, would be recovered from the salary. An undertaking in this regard should be obtained from the beneficiary before extending MACP benefit to him.

Before implementation of pay fixation in respect of individual officers it is advised to ensure the correctness of the name, date of birth, date of entry in the Government Service as direct recruit, existing Pay Band with Grade Pay, upgraded pay band with grade pay, date of eligibility etc. and if any discrepancy is detected, the same may be immediately brought to this notice of this office.
