Sir,

Sub: Installation of biometric attendance system... probable difficulties needs to resolve immediately.

Kindly refer to our earlier letter on the above subject, With utmost displeasure it is being observed that machines on biometric attendance system are installed in every offices under your jurisdiction. In spite of our repeated approach to the C.Cs of different formations under CBEC, Kolkata. nothing has been improved and without rectifying the office ambience as indicated by the Associations the issue is being implemented in this office and other offices of Central Excise, customs & service tax Kolkata in a hest.

In this regard, we would like to restate that

- Because of the poor road condition (6% of total vacant space available) & congestion of vehicular traffic, office vehicles should be provided from Major Railway Stations (Viz: Sealdah & Howrah) to reach office in time.
- Clear guideline should be given to enable officers working in Law, Preventive & Audit Commissionerate and ranges and other sections who require frequent movement from their office.
- Proper seating arrangement of different category of officers, people in service tax and in Haldia & Siliguri Central Excise & Service Tax Commissionerate are presently seating in a horrible condition.
- All the offices all over West Bengal Sikkim & Andaman Nicobor Island should be equipped with decent canteen as it is operative in CBDT, authority should ensure installation of proper canteen in every offices.
- Tea/ coffee should mandatorily be served at least thrice a day without fail.
- Clean toilets are part of Swach Bharat Avijan but are absent in our offices.

In absence of above arrangements implementation of biometric attendance system would be an oppression upon the employees; this platform demands uniform implementation of the BAS for each and every employee.


