NOTICE FOR ELECTION TO THE CIRCLE COMMITTEE & THE 7th CIRCLE CONVENTION

This is to notify that in terms of Chapter 4, Article 16 of the Constitution of the All India Central Excise Inspectors' Association, West Bengal, Sikkim & Andaman Nicobar Circle, a federating unit of the All India Central Excise Inspectors' Association, and as resolved in the Circle Committee meeting held on 3rd February'2021, the election of 23 members for the Circle Committee shall be held on 04.03.2021 in North Bengal, South Bengal & Kolkata Zones on the same day. Three Circle Committee Members of North Bengal, Three Circle Committee Members of South Bengal & Seventeen Circle Committee Members of Kolkata Zone will be elected by the general members of respective zones only (Jurisdiction given below).

If any member will not be in his/her place of posting on the date of election, he/she may inform his/her Asstt. Returning Officer that he/she will not be in his/her place of posting and he/she may be allowed to cast his/her vote in another booth of the same zone by giving a simple declaration to the Asstt. Returning Officer/Presiding Officer of both where he/she desires to cast his/her vote and he/she has not cast his/her vote in his/her original place of posting. Returning Officer and Asstt. Returning should ensure that no members can cast his/her vote in two places. Any member cast his/her vote in his/her convenient place after giving a declaration to the Returning Officer and also to the Asstt. Returning Officer.

JURISDICTION

North Bengal Zone : Sikkim, all six districts of North Bengal upto Malda. All CGST & CX, Audit Circles, Siliguri Appeal Commissionerate and also the Customs Offices in this area.

South Bengal Zone: Areas covered by Bolpur & Durgapur Audit Commissionerate and different Customs Offices of CCP situated in this area.

Kolkata Zone : Areas covered by Kolkata South, North, Haldia & Howrah Commissionerate, Audit-I&II Commissionerate, CC(P), W.B. Principal Chief Commissioner Offices of CGST & CX, Appeal-I&II Commissionerate, Different Customs Offices of CCP situated in North 24 parganas, South 24 parganas, Kolkata, Nadia.

RETURNIGN OFFICER

In terms of Article 16(b)(2) of the Association Constitution, the Central Committee hereby appoints Sri Saurav Biswas, Superintendent of CGST & CX, Barabazar Division, Kolkata North Commissionerate, Room No.22.6, GST BHAWAN, Kolkata-700107 as the Returning officer for conducting election.

The election shall be held through secret ballot amongst those members otherwise eligible to vote and who have filed nominations.

The returning officer shall notify (i) name of the Assistant Returning officer(s), (ii) Polling booths with names of corresponding Presiding Officers at least 07 days before the date of election.

Any dispute regarding the election process shall be brought to the knowledge of the Returning Officer and complaint/grievance related to the election shall be lodged with him and decisions taken by the Returning Officer on such matters shall be final.

Election shall be held and counting shall be done in presence of Returning/Assistant Returning Officers or any other person having prior delegation of power by the Returning officer and shall have to be completed within the stipulated time given above.

After completion of counting, the Returning officer shall declare the results, and he shall issue certificate to the elected Central Committee members.

The function of Returning Officer commences with the issuance of this notice and shall be restricted upto the completion of counting of ballot papers and issuance of certificates to the elected Central Committee members.

The Returning officer shall be competent to adopt suitable measures and issue instructions/ notifications for smooth conducting of the Election as per terms and conditions in this notice and in conformity with the provisions of the Association constitution.
